I am/We are aware that if my/our property is part of a Body Corporate, then I/we can be billed under the Allocation Tariff, only if all properties in the Body Corporate indicate their preference for the Allocation Tariff.

I/We understand that the Allocation Charge under the Allocation Tariff is \$990 per annum (to be billed in two equal biannual instalments) for single dwelling residential properties. Where the assessment is a multi-dwelling property, the Allocation Charge will be \$990 per annum for the first unit or flat and \$743 per annum for each additional unit or flat from the 2nd unit or flat onwards.

I/We understand that under the Allocation Tariff, single dwelling properties will be entitled to use a total quantity of 650 kilolitres of water per annum, as measured by the water meter, for no additional charge and multi-unit properties will be entitled to 650 kilolitres per annum for the first unit or flat and 488 kilolitres per annum per unit or flat from the 2nd unit or flat onwards, for no additional charge. (Allocated Quantity)

I/We also understand that under the Allocation Tariff, should I/We consume any water in excess of the Allocated Quantity, we will incur the Excess Water Consumption Charge of \$5.60 per kilolitre for each and every kilolitre used in excess of the Allocated Quantity.

I am/We are aware that the Allocation Tariff will be binding on me/us and I/we will be charged in accordance with the Allocation Tariff for the full 2020/21 financial year.

I/We understand that use of water is subject to any water conservation measures (water restrictions) that are currently in place, or that may be imposed by Council at any time during the financial year and that if I am/we are unable to use the Allocated Quantity as a result, I/we have no ability to change to the Two-Part Tariff nor have any recourse or other right of compensation against Council.
